

EMPLOYMENT APPEALS BOARD DECISION
2020-EAB-0136

Affirmed
Request to Reopen Denied

PROCEDURAL HISTORY: On August 15, 2019, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant was not available for work during the week including July 28 through August 3, 2019 (decision # 151350). Claimant filed a timely request for hearing. On August 23, 2019, the Office of Administrative Hearings (OAH) mailed notice of a hearing scheduled for September 5, 2019 at 9:30 a.m. On September 5, 2019, ALJ Murdock issued Order No. 19-UI-136163 dismissing claimant's request for hearing for his failure to appear on September 5, 2019, leaving decision # 151350 undisturbed.

On September 12, 2019, claimant filed a timely request to reopen the September 5th hearing. On September 23, 2019, OAH mailed notice of a hearing scheduled for October 7, 2019 at 1:30 p.m. to consider claimant's request to reopen, and if granted, the merits of decision #151350. On October 7, 2019, ALJ Seideman issued Order No. 19-UI-137684 dismissing claimant's request for hearing for his failure to appear on October 7, 2019, again leaving decision # 151350 undisturbed. On October 28, 2019, Order No. 19-UI-137684 became final without claimant have filed a timely request to reopen.

On November 29, claimant filed a late request to reopen the October 7th hearing. On January 7, 2020, OAH mailed notice of a hearing scheduled for January 21, 2020 at 8:15 a.m. to consider claimant's request to reopen the October 7th hearing, and if granted, claimant's request to reopen the September 5th hearing, and if granted, the merits of decision #151350. On January 21, 2020, ALJ Murdock conducted a hearing, and on January 29, 2020, issued Order No. 20-UI-143505, denying claimant's request to reopen. On February 11, 2020, claimant filed a timely application for review of Order No. 20-UI-143505 with the Employment Appeals Board (EAB).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 20-UI-143505 is affirmed.
