

EMPLOYMENT APPEALS BOARD DECISION
2020-EAB-0156

Affirmed
Request to Reopen Denied

PROCEDURAL HISTORY: On November 6, 2019, the Oregon Employment Department (the Department) served notice of an administrative decision concluding the employer discharged claimant for misconduct, and disqualifying claimant from benefits effective October 13, 2019 (decision # 90844). Claimant filed a timely request for hearing. On November 19, 2019, the Office of Administrative Hearings (OAH) mailed to claimant notice of a hearing scheduled for December 3, 2019, at which time claimant failed to appear. On December 3, 2019, ALJ Snyder issued Order No. 19-UI-140578, dismissing claimant's request for hearing for failure to appear. On December 11, 2019, claimant filed a timely request to reopen the December 3, 2019 hearing. On January 8, 2020, OAH mailed to claimant notice of a hearing scheduled for January 22, 2020, at which time claimant failed to appear again. On January 23, 2020, ALJ M. Davis issued Order No. 19-UI-143145, dismissing claimant's request to reopen and concluding that Order No. 19-UI-140578, dismissing claimant's request for hearing on decision # 90844, remained undisturbed. On January 28, 2020, claimant filed a timely request to reopen the January 22, 2020 hearing. ALJ Kangas reviewed claimant's request, and on February 11, 2020, issued Order No. 20-UI-144297, denying the request. On February 19, 2020, claimant filed an application for review with the Employment Appeals Board (EAB).

EAB did not consider claimant's written argument written on their application for review when reaching this decision because they did not include a statement declaring that they provided a copy of their argument to the opposing party or parties as required by OAR 471-041-0080(2)(a) (May 13, 2019). Even if EAB had considered claimant's argument, the outcome of this decision would remain the same for the reasons explained in Order No. 20-UI-144297.

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 20-UI-144297 is affirmed.
