

**EMPLOYMENT APPEALS BOARD DECISION**  
**2020-EAB-0163**

*Application for Review Dismissed*

**FINDINGS OF FACT AND PROCEDURAL HISTORY:** On December 5, 2019, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant was discharged not for misconduct (decision # 160530). The employer filed a timely request for hearing. On January 29, 2020, ALJ Logan conducted a hearing, and on January 30, 2020, issued Order No. 20-UI-143602, affirming the Department's decision. On February 19, 2020, Order No. 20-UI-143602 became final without the employer having filed an application for review with the Employment Appeals Board (EAB). Order No. 20-UI-143602 stated that any appeal of that order had to be filed on or before February 19, 2020 to be timely. On February 20, 2020, the employer filed a late application for review with EAB.

EAB did not consider the employer's written argument when reaching this decision because they did not include a statement declaring that they provided a copy of their argument to the opposing party or parties as required by OAR 471-041-0080(2)(a) (May 13, 2019).

**CONCLUSIONS AND REASONS:** The application for review should be dismissed.

On February 20, 2020, the appellant filed an application for review of Order No. 20-UI-143602 with the EAB.<sup>1</sup> ORS 657.270(6) and ORS 657.270(7)(b) required the application for review to be filed no later than February 19, 2020. The deadline for filing a late application for review may be extended under certain circumstances. OAR 471-041-0070. In order to be considered for such an extension, however, an individual must include "a written statement describing the circumstances that prevented a timely filing." OAR 471-041-0070(3). The appellant provided no explanation as to why the application was filed after the filing deadline expired. Accordingly, the application for review is dismissed.

**DECISION:** The application for review filed February 20, 2020 is dismissed. Order No. 20-UI-143602 remains undisturbed.

<sup>1</sup> Under OAR 471-041-0065, the "filing date" of an application for review filed by mail is the postmark date on the envelope in which the application was sent. The postmark date on the envelope the appellant used to file the application for review was February 20<sup>th</sup>. Therefore, the filing date was February 20<sup>th</sup>.
