EMPLOYMENT APPEALS BOARD DECISION
2020-EAB-0165

*Affirmed
Disqualification*

PROCEDURAL HISTORY: On January 15, 2020, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant voluntarily left work without good cause, and was disqualified from receiving unemployment insurance benefits effective December 15, 2019 (decision # 102535). Claimant filed a timely request for hearing. On February 11, 2020, ALJ Wyatt conducted a hearing, and on February 14, 2020, issued Order No. 20-UI-144515, concluding claimant voluntarily left work without good cause, and was disqualified from receiving unemployment insurance benefits effective December 22, 2019. On February 21, 2020, claimant filed an application for review with the Employment Appeals Board (EAB).

EVIDENTIARY MATTER: The ALJ admitted Exhibit 1 into evidence, but failed to mark the exhibit. As a clerical matter, EAB identified the exhibit based on the ALJ's description of it, and marked it as Exhibit 1. Audio Record at 5:21 to 6:30.

WRITTEN ARGUMENT: The written argument from claimant and the employer contained information that was not part of the hearing record, and did not show that factors or circumstances beyond the reasonable control of the claimant or the employer prevented them from offering the information during the hearing. Under ORS 657.275(2) and OAR 471-041-0090 (May 13, 2019), EAB considered only information received into evidence at the hearing when reaching this decision.

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 20-UI-144515 is affirmed.
