## **EMPLOYMENT APPEALS BOARD DECISION** **2020-EAB-0169**

*Affirmed  
Late Request for Hearing Dismissed  
Overpayment Assessed*

**PROCEDURAL HISTORY:** On October 30, 2019, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant was not available for work during the weeks including September 29 through October 26, 2019 and until the reason for the denial had ended and was ineligible for benefits (decision # 122811). Decision # 122811 stated that the deadline for claimant to appeal was November 19, 2019 and that if claimant was paid benefits for any week covered by the decision, she might have to pay those benefits back. On November 19, 2019, decision # 122811 became final without claimant having filed a timely request for hearing. On December 16, 2019, the Department served notice of another administrative decision, based on decision # 122811, assessing a \$1,128 overpayment that claimant was required to repay to the Department (decision # 125256). Decision # 125256 stated that the deadline for claimant to appeal that decision was January 6, 2020. On December 26, 2019, claimant filed a late request for hearing on decision # 122811 and a timely request for hearing on decision # 125256.

On January 15, 2020, the Office of Administrative Hearings (OAH) served notice of a consolidated hearing on claimant's requests for hearings on decisions # 122811 and 125256 scheduled for January 28, 2020. On January 28, 2020, ALJ Frank conducted a consolidated hearing, and on January 31, 2020, issued Order No. 20-UI-143658, dismissing claimant's request for hearing regarding decision # 122811 as late without a showing of good cause, leaving decision #122811 undisturbed, and Order No. 20-UI-143657, affirming decision # 125256.

On February 19, 2020, claimant filed timely applications for review of Orders No. 20-UI-143658 and 20-UI-143657 with the Employment Appeals Board (EAB). Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Orders No. 20-UI-143658 and 20-UI-143657. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2020-EAB-0168 and 2020-EAB-0169, respectively).

EAB considered claimant's written argument to the extent it was based on the hearing record.

EAB reviewed the entire consolidated hearing record. On *de novo* review and pursuant to ORS 657.275(2), Orders No. 20-UI-143658 and 20-UI-143657 are **adopted**.

**DECISION:** Orders No. 20-UI-143658 and 20-UI-143657 are affirmed.
