

EMPLOYMENT APPEALS BOARD DECISION
2020-EAB-0170

Application for Review Dismissed

FINDINGS OF FACT AND PROCEDURAL HISTORY: On December 31, 2019, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant quit work without good cause and was disqualified from benefits beginning on November 10, 2019 (decision # 84927). Claimant filed a timely request for hearing. On January 29, 2020, ALJ Monroe conducted a hearing, and on January 31, 2020, issued Order No. 20-UI-143743, modifying the Department's decision and concluding claimant quit work without good cause and was disqualified from benefits beginning on November 17, 2019. Order No. 20-UI-143743 stated that any appeal of that order must be filed on or before February 20, 2020. On February 20, 2020, Order No. 20-UI-143743 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On February 25, 2020, claimant filed a late application for review with EAB.

CONCLUSIONS AND REASONS: The application for review should be dismissed.

On February 25, 2020, the appellant filed an application for review of Order No. 20-UI-143743 with the EAB. ORS 657.270(6) required the application for review to be filed no later than February 20, 2020. The deadline for filing an application for review may be extended under certain circumstances. OAR 471-041-0070 (May 13, 2019). In order to be considered for such an extension, an individual must include "a written statement describing the circumstances that prevented a timely filing." OAR 471-041-0070(3). Claimant included with his application for review written information describing the circumstances that prevented him from filing the application on time. In that statement, claimant asserted, "My child spilled a cup of juice on my mail and I wasn't sure of the exact date." Claimant also asserted that he "needed to see the doctor again before the review and [he was] finally able to get an appointment . . . so [he could] give the proper paperwork over at the hearing." Claimant's Late Application for Review. The reasons claimant provided would not have prevented claimant from filing the application for review in a timely manner. When claimant realized he was unable to read the filing deadline on the order, claimant could have contacted the Office of Administrative Hearings or the Department to confirm the filing deadline. Claimant did not need to obtain additional information from his doctor to file an application for review, therefore his difficulty in getting an appointment with his doctor did not prevent a timely filing. Claimant did not show that factors or circumstances beyond his reasonable control prevented his timely filing. Accordingly, the application for review is dismissed.

DECISION: The application for review filed February 25, 2020 is dismissed. Order No. 20-UI-143743 remains undisturbed.
