

EMPLOYMENT APPEALS BOARD DECISION
2020-EAB-0202

Affirmed
Disqualification

PROCEDURAL HISTORY: On December 20, 2019, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant voluntarily quit working for the employer without good cause and was disqualified from receiving benefits beginning December 1, 2019 (decision # 101356). Claimant filed a timely request for hearing. On February 12, 2020, ALJ Frank conducted a hearing, and on February 20, 2020, issued Order No. 20-UI-144825, affirming the Department's decision. On March 7, 2020, claimant filed an application for review with the Employment Appeals Board (EAB).

Claimant submitted written argument with her application for review. However, claimant did not declare that she provided a copy of her argument to the opposing party or parties as required by OAR 471-041-0080(2)(a) (May 13, 2019). The argument also contained additional evidence in the form of a copy of claimant's resignation letter, which was partially cumulative of testimony received at the hearing. To the extent information within the resignation letter was not cumulative, claimant has not demonstrated that factors or circumstances beyond her reasonable control prevented her from the offering the resignation letter into the hearing record. OAR 471-041-0090(1)(b) (May 13, 2019). EAB therefore considered only information received into evidence at the hearing when reaching this decision. *See* ORS 657.275(2).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 20-UI-144825 is affirmed.
