

EMPLOYMENT APPEALS BOARD DECISION
2020-EAB-0230

Affirmed
Overpayment Assessed

PROCEDURAL HISTORY: On November 15, 2019, the Oregon Employment Department (the Department) served notice of an administrative decision assessing a \$160 overpayment (decision # 193550). Claimant filed a timely request for hearing. On February 21, 2020, ALJ Janzen conducted a hearing, and on February 25, 2020 issued Order No. 20-UI-145042, modifying the Department's overpayment assessment to \$16. On March 16, 2020, the Department filed an application for review with the Employment Appeals Board (EAB).

The Department submitted written argument to EAB asserting that the overpayment to claimant should have been calculated as \$3, not \$16. The \$3 overpayment amount was based on the Department's argument that the appropriate minimum wage to utilize when making the calculation required by ORS 657.150(6)(a) was the "urban county" rate for the relevant time period found in ORS 653.025(2) and that ORS 653.036 expressly lists Jackson County (the relevant county for purposes of this case) as an "urban county" for purposes of ORS 653.025. Contrary to the Department's argument, ORS 653.026 defines "[n]onurban counties" (not "urban" counties) for purposes of ORS 653.025, and Jackson County is not listed as a nonurban county. Likewise, Jackson County is not "located within the urban growth boundary of a metropolitan service district," such that the minimum wage amount listed in ORS 653.025(2) would be relevant to this case. Instead, the ALJ appropriately applied the standard minimum wage rate listed in ORS 653.025(f) when making the calculations required by ORS 657.150(6)(a), and correctly concluded that claimant's overpayment amount was \$16.

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 20-UI-145042 is affirmed.
