

EMPLOYMENT APPEALS BOARD DECISION
2020-EAB-0233

Late Application for Review Dismissed

PROCEDURAL HISTORY: On January 21, 2020, the Oregon Employment Department (the Department) served notice of an administrative decision concluding the employer discharged claimant for misconduct and claimant therefore was disqualified from receiving unemployment insurance benefits effective December 15, 2019 (decision # 135409). Claimant filed a timely request for hearing. On February 18, 2020, ALJ Scott conducted a hearing, and on February 21, 2020 issued Order No. 20-UI-144922, affirming the Department's decision. On March 12, 2020, Order No. 20-UI-144922 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On March 17, 2019, claimant filed a late application for review with EAB.

CONCLUSIONS AND REASONS: Claimant's late application for review of Order No. 20-UI-144922 is dismissed.

An application for review is timely if it is filed within 20 days of the date that OAH mailed the decision for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20 day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

On March 17, 2020, the appellant filed an application for review of Order No. 20-UI-144922 with EAB. ORS 657.270(6) and ORS 657.270(7)(b) required the application for review to be filed no later than March 12, 2020. The application for review therefore was late, and although the appellant included a written statement with their application for review, that statement provided no explanation as to why the application was filed after the filing deadline expired. Accordingly, the application for review is dismissed.

DECISION: The application for review filed March 17, 2020 is dismissed. Order No. 20-UI-144922 remains undisturbed.
