

**EMPLOYMENT APPEALS BOARD DECISION**  
**2020-EAB-0235**

*Order No. 20-UI-145601 Affirmed – Disqualification*  
*Order No. 20-UI-145464 Affirmed – Ineligible Weeks 2-20 through 8-20*

**PROCEDURAL HISTORY:** On January 29, 2020, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant voluntarily quit working for the employer without good cause (decision # 121922), and an administrative decision concluding claimant was not available for work from January 5, 2020 through January 25, 2020 (decision # 114728). Claimant filed timely requests for hearing of both decisions.

On March 2, 2020, ALJ Murdock conducted a hearing on decision # 121922, and on March 4, 2020 issued Order No. 20-UI-145601, affirming that decision. On March 2, 2020, ALJ Lohuis conducted a hearing on decision # 114728, and on March 3, 2020 issued Order No. 20-UI-145464, modifying that decision by concluding that claimant was not available for work from January 5, 2020 through February 22, 2020. On March 17, 2020, claimant filed an application for review of Order Nos. 20-UI-145601 and 20-UI-145464 with the Employment Appeals Board (EAB).

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Order Nos. 20-UI-145601 and 20-UI-145464. For case tracking purposes, this decision is being issued in duplicate (EAB Decisions 2020-EAB-0235 and 2020-EAB-0236, respectively).

Claimant submitted written argument on March 17, 2020 and March 24, 2020, asserting, in part, that due to the impact of the corona virus her in-person school practicum hours were no longer in effect, and her master's degree program was now being conducted entirely online. Whether a claimant is available for work for purposes of ORS 657.155(1)(c), however, is a determination that is made by looking at the claimant's availability at the time of any week claimed. As such, claimant's current availability is irrelevant to her availability during the weeks claimed, as the record under review does not show that claimant was similarly available for work between January 5, 2020 and February 22, 2020. If the circumstances that caused the Department to deny benefits in this case based on claimant's unavailability have changed since February 22, 2020, claimant may notify the Department of her changed circumstances directly. EAB did not consider the remainder of claimant's written arguments directed at Order No. 20-UI-145601 when reaching this decision because she did not include a statement

declaring that she provided a copy of her argument to the employer as required by OAR 471-041-0080(2)(a) (May 13, 2019).

EAB reviewed both hearing records. On *de novo* review and pursuant to ORS 657.275(2), the orders under review are **adopted**.

**DECISION:** Orders No. 20-UI-145601 and 20-UI-145464 are affirmed.
