EMPLOYMENT APPEALS BOARD DECISION 2020-EAB-0250

Affirmed Ineligible Week 03-20

PROCEDURAL HISTORY: On February 3, 2020, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant was not able, available or actively seeking work during the week of January 12 through January 18, 2020 and was ineligible for benefits for that week (decision # 144757). Claimant filed a timely request for hearing. On March 13, 2020, ALJ Frank conducted a hearing, and on March 20, 2020 issued Order No. 20-UI-146657, concluding claimant was ineligible for benefits the week of January 12 through January 18, 2020 because he was not available for work during that week. On March 26, 2020, claimant filed an application for review with the Employment Appeals Board (EAB).

Claimant submitted a written argument in support of his application for review. Claimant asserted that the hearing proceedings were "unfair" because the ALJ "did not want" OAR 471-030-0036(2)(a), which he believed supported his position, to be admitted into evidence. Written Argument at 1. However, that rule was already included in the hearing record as an attachment to the February 27, 2020 Notice of Hearing in this case. Notice of Hearing at 13.

ORS 657.155(1)(c) provides that to be eligible to receive benefits, unemployed individuals must be able to work, available for work, and actively seek work during each week claimed. Claimant was "able to work" under OAR 471-030-0036(2)(a) (December 8, 2019) because that rule provides that "[a]n occasional and temporary disability for less than half of the week shall not result in a finding that the individual is unable to work for that week," and claimant was temporarily disabled for only three days during the week at issue. However, claimant was not "available for work" that week under OAR 471-030-0036(3)(f). That rule provides, "[f]or the purposes of ORS 657.155(1)(c), an individual is not available for work in any week claimed in which the individual has an opportunity to perform suitable work and fails to accept or report for such work due to illness, injury or other temporary physical or mental incapacity," and claimant was not both able to work and available for work during the week at issue claimant was not both able to work and available for work during the week at issue as required by ORS 657.155(1)(c), he was not eligible for benefits for that week.

EAB reviewed the hearing record in its entirety, which shows that the ALJ inquired fully into the matters at issue and gave all parties reasonable opportunity for a fair hearing as required by ORS 657.270(3) and (4) and OAR 471-040-0025(1) (August 1, 2004). On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 20-UI-146657 is affirmed.
