EMPLOYMENT APPEALS BOARD DECISION 2020-EAB-0253-R

On Reconsideration, Late Applications for Review Allowed Order No. 20-UI-144419 ~ Affirmed ~ Request to Backdate Not Allowed Order No. 20-UI-144420 ~ Affirmed ~ Ineligible Weeks 45-19 through 47-19

FINDINGS OF FACT AND PROCEDURAL HISTORY: On December 19, 2019, the Oregon Employment Department (the Department) served notice of two administrative decisions, one denying claimant's request that her initial claim for benefits be backdated to November 3, 2019 (decision # 161143), and the other concluding claimant did not actively seek work from November 3, 2019 through November 23, 2019 (decision # 161406). Claimant filed timely requests for hearings on both decisions. On February 5, 2020, ALJ Wyatt conducted a hearing on both decisions, and on February 13, 2020, issued Order No. 20-UI-144419, affirming decision # 161143, and Order No. 20-UI-144420, affirming decision # 161406. On March 4, 2020, Orders No. 20-UI-144419 and 20-UI-144420 became final without claimant having filed applications for review with the Employment Appeals Board (EAB). On March 21, 2020, claimant filed late applications for review with EAB. On April 1, 2020, EAB issued Appeals Board Decisions 2020-EAB-0253 and 2020-EAB-0254, dismissing claimant's applications for review without prejudice because they were late and leaving Orders No. 20-UI-144419 and 20-UI-144420 undisturbed. On April 1, 2020, claimant filed timely requests for reconsideration of Appeals Board Decisions 2020-EAB-0253 and 2020-EAB-0254 with EAB.

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Orders Nos. 20-UI-144419 and 20-UI-144420. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2020-EAB-0253-R and 2020-EAB-0254-R).

EAB Decisions 2020-EAB-0253-R and 2020-EAB-0254-R are issued pursuant to EAB's authority under ORS 657.290(3).

RECONSIDERATION: ORS 657.290(3) authorizes EAB to reconsider any previous decision of the Employment Appeals Board, including "the making of a new decision to the extent necessary and appropriate for the correction of previous error of fact or law." The request is subject to dismissal unless it is filed on or before the 20th day after the decision sought to be reconsidered was mailed. OAR 471-041-0145(2).

EAB dismissed claimant's late applications for review without prejudice and subject to her filing timely requests for reconsideration within 20 days after EAB's dismissal decisions were issued. Claimant filed requests for reconsideration consistent with the requirements set forth in OAR 471-041-0145. The requests for reconsideration are, therefore, allowed.

LATE APPLICATIONS FOR REVIEW: The appellant filed late applications for review of Order Nos. 20-UI-144419 and 20-UI-144420 with the EAB. The deadline for filing applications for review may be extended a reasonable time upon a showing of good cause. *See* ORS 657.875; OAR 471-041-0070. The request is subject to dismissal unless it includes a statement that a copy was provided to the other parties, and is filed within 20 days of the date the Orders under review were mailed.

Claimant showed that she had good cause to extend the deadline for filing applications for review a reasonable time due to her health condition, work demands as a health care provider during a pandemic, exposure to Covid-19, and quarantine. Claimant's late applications for review are, therefore allowed, and EAB will review the merits of Orders No. 20-UI-144419 and 20-UI-144420.

MERITS REVIEW: EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the orders under review are **adopted**.

DECISION: Orders No. 20-UI-144419 and 20-UI-144420 are affirmed.
