EMPLOYMENT APPEALS BOARD DECISION 2020-EAB-0254

Application for Review Dismissed Without Prejudice

FINDINGS OF FACT AND PROCEDURAL HISTORY: On December 19, 2019, the Oregon Employment Department (the Department) served notice of two administrative decisions, one denying claimant's request that her initial claim for benefits be backdated to November 3, 2019 (decision # 161143), and the other concluding claimant did not actively seek work from November 3, 2019 through November 23, 2019 (decision # 161406). Claimant filed timely requests for hearings on both decisions. On February 5, 2020, ALJ Wyatt conducted a hearing on both decisions, and on February 13, 2020, issued Order No. 20-UI-144419, affirming decision # 161143, and Order No. 20-UI-144420, affirming decision # 161406. On March 4, 2020, Orders No. 20-UI-144419 and 20-UI-144420 became final without claimant having filed applications for review with the Employment Appeals Board (EAB). On March 21, 2020, claimant filed late applications for review with EAB.

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Orders Nos. 20-UI-144419 and 20-UI-144420. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2020-EAB-0253 and 2020-EAB-0254).

CONCLUSIONS AND REASONS: The applications for review should be dismissed without prejudice.

On March 21, 2020, the appellant filed applications for review of Order Nos. 20-UI-144419 and 20-UI-144420 with the EAB. ORS 657.270(6) and ORS 657.270(7)(b) required the applications for review to be filed no later than March 4, 2020. The appellant's applications for review are therefore late, and the applications for review are dismissed.

The deadline for filing applications for review may be extended a reasonable time upon a showing of good cause. *See* ORS 657.875; OAR 471-041-0070. If the appellant believes they have good cause and filed their late application for review within a reasonable time, the appellant may request that EAB reconsider this decision under OAR 471-041-0145.

EAB will dismiss any requests for reconsideration that does not include all five of the following:

- 1. The appellant must file the request for reconsideration within 20 days of the date this decision was mailed, April 21, 2020, and
- 2. The appellant must include a statement on the request for reconsideration declaring that they sent a copy of the request to the other party, *and*
- 3. The appellant must provide additional specific details about the reason they filed a late application for review. For example, the appellant should include specific information about the date they received the ALJ's order, whether they read it, whether they agreed or disagreed with the ALJ's order, the reason(s) why they did not file the application for review before the deadline, whether they or their families were ill or quarantined around the deadline, whether they could not file a timely application for review for any other reason(s) not related to illness or quarantine, how that affected their ability to file a timely application for review, and any other specific details that might help EAB determine whether or not the appellant had "good cause," which means factors or circumstances beyond their reasonable control prevented them from filing a timely application for review, and
- 4. The appellant must provide the date the circumstances that prevented them from filing a timely application for review (which they listed in response to #3, above) ceased to exist, *and*
- 5. The appellant must provide sufficient information to prove that they filed their application for review within seven days of that date.

The appellant may file a request for reconsideration in many ways; please note that you need only file *one* request for reconsideration:

- 1. Use your smart phone, tablet, or computer to fill out the "File a Written Argument" form, available on EAB's website: <u>https://www.oregon.gov/EMPLOY/EAB/Pages/default.aspx</u>, or
- 2. Use your smart phone, tablet, or computer to send an email to EAB at OED_EAB_OFFICE@oregon.gov, or

- 4. Send EAB a fax at 503-378-2129.

DECISION: The applications for review filed March 21, 2020 are dismissed without prejudice. Orders No. 20-UI-144419 and 20-UI-144420 remain undisturbed.
