

EMPLOYMENT APPEALS BOARD DECISION
2020-EAB-0273

Application for Review Dismissed

FINDINGS OF FACT AND PROCEDURAL HISTORY: On July 11, 2019, the Oregon Employment Department (the Department) served notice of an administrative decision concluding the employer suspended claimant but not for misconduct (decision # 92223). The employer filed a timely request for hearing but withdrew their request before a hearing was held. On July 25, 2019, ALJ Seideman issued Order No. 19-UI-133986, concluding the hearing was dismissed for employer withdraw. On March 25, 2020, claimant filed a late application for review with the Employment Appeals Board (EAB).

CONCLUSIONS AND REASONS: The appellant's application for review should be dismissed.

On March 25, 2020, the Employment Appeals Board (EAB) received from the appellant what appears to be a late application for review of an order that *allowed* the appellant benefits. The appellant did not assign error to any portion of that order, did not request reversal of any portion of the order, and alleged no facts entitling the appellant to further relief in this matter. Accordingly, there is no justiciable controversy before EAB based upon the appellant's application for review. *See accord Barcik v. Kubiacyk*, 321 Or 174, 895 P2d 765 (1995). Because the case before us presents no justiciable controversy, the application for review of Order No. 19-UI-133986 is dismissed. Order No. 19-UI-13986 remains undisturbed.

This dismissal applies only to claimant's suspension from work, and the Department's decision # 92223 that *allowed* claimant benefits. If claimant has been *denied* benefits for any other reason(s), claimant should contact the Department directly to request hearings in those cases.

DECISION: The application for review filed March 25, 2020 is dismissed. Order No. 19-UI-133986 remains undisturbed.
