

EMPLOYMENT APPEALS BOARD DECISION
2020-EAB-0274

Affirmed
Request to Reopen Denied

PROCEDURAL HISTORY: On December 23, 2019, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant quit work without good cause and was disqualified from receiving unemployment insurance benefits effective September 15, 2019 (decision # 83928). Claimant filed a timely request for hearing. On January 22, 2020, the Office of Administrative Hearings mailed notice of a hearing scheduled for February 4, 2020 at 8:15 a.m. On February 4, 2020, ALJ Frank conducted a hearing, at which claimant failed to appear, and issued Order No. 20-UI-143867, dismissing claimant's request for hearing for failing to appear, leaving decision # 83928 undisturbed. Order No. 20-UI-143867 stated that if a party did not appear at the hearing, the party had the option to file a request to reopen the hearing within 20 days of the date the order from the hearing missed was mailed. On February 24, 2020, Order No. 20-UI-143867 became final without claimant having filed a timely request to reopen.

On March 18, 2020, claimant filed a late request to reopen the February 4, 2020 hearing. ALJ Kangas reviewed the record and claimant's late request to reopen, and on March 19, 2020, issued Order No. 20-UI-146584, denying claimant's request to reopen as late without a showing of good cause. On March 31, 2020, claimant filed a timely application for review of Order No. 20-UI-146584 with the Employment Appeals Board (EAB). With his application for review, claimant submitted a written argument. EAB considered claimant's argument to the extent it was based on the hearing record.

EAB reviewed the entire record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**. Order No. 20-UI-143867 remains undisturbed.

DECISION: Order No. 20-UI-146584 is affirmed.
