EMPLOYMENT APPEALS BOARD DECISION 2020-EAB-0275

Order No. 20-UI-145642 ~ Application for Review Dismissed Order No. 20-UI-145641 Affirmed ~ Late Request for Hearing Dismissed

PROCEDURAL HISTORY AND FINDINGS OF FACT: On January 14, 2020, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant failed to provide information requested by the Department and was therefore ineligible to receive unemployment insurance benefits for the week of December 22, 2019 through December 28, 2019, and until claimant provided the information. On January 16, 2020, the Department served notice of another administrative decision, which concluded that claimant failed to provide information requested by the Department and was therefore ineligible to receive unemployment insurance benefits for the week of December 29, 2019 through January 4, 2020 and until claimant provided the information (decision # 125909). On February 3, 2020, the January 14, 2020 decision became final without claimant having filed a request for hearing. On February 5, 2020, decision # 125909 became final without claimant having filed a request for hearing.

On February 29, 2020, claimant filed late requests for hearings on the January 14, 2020 decision and decision # 125909. On March 5, 2020, ALJ Kangas issued Order No. 20-UI-145642, dismissing claimant's late request for hearing on the January 14, 2020 decision subject to claimant's right to renew the request by responding to an appellate questionnaire by March 19, 2020. On March 6, 2020, ALJ Kangas issued Order No. 20-UI-145641, dismissing claimant's late request for hearing on decision # 125909 subject to claimant's right to renew the request by responding to an appellate questionnaire by responding to an appellate questionnaire by responding to an appellate questionnaire by march 20, 2020. On March 25, 2020, Order No. 20-UI-145642 became final without claimant having filed an application for review with the Employment Appeals Board (EAB).

On March 26, 2020, claimant filed a late response to the appellant questionnaire for both decisions with the Office of Administrative Hearings (OAH), along with a late application for review of Order No. 20-UI-145642 and a timely application for review of Order No. 20-UI-145641 with the Employment Appeals Board (EAB). On March 31, 2020, ALJ Kangas issued letters stating that because claimant's questionnaire response was late, OAH would not consider it, and Orders No. 20-UI-145642 and No. 20-UI-145641 would remain in effect. This matter is before EAB based on claimant's late application for review of Order No. 20-UI-145642 and timely application for review of Order No. 20-UI-145641.

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Orders No. 20-UI-145642 and 20-UI-145641. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2020-EAB-0276 and 2020-EAB-0275).

EAB considered the entire hearing record. Based on a *de novo* review and pursuant to ORS 657.275(2), Order No. 20-UI-145641 dismissing claimant's late request for hearing on decision # 125909 is **adopted**.

CONCLUSIONS AND REASONS: Claimant's late application for review of Order No. 20-UI-145642 is dismissed. Order No. 20-UI-145642, dismissing claimant's request for hearing on the January 14, 2020 decision remains undisturbed.

An application for review is timely if it is filed within 20 days of the date that OAH mailed the decision for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20 day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

On March 26, 2020, claimant filed a late application for review of Order No. 20-UI-145642 with the EAB. ORS 657.270(6) required the application for review to be filed no later than March 25, 2020. Although the deadline for filing an application for review may be extended under certain circumstances, to be considered for such an extension, an individual must include "a written statement describing the circumstances that prevented a timely filing." OAR 471-041-0070(3). Claimant included a written statement with his application for review, but the statement did not include any information explaining why claimant waited until March 26, 2020, after the filing deadline expired, to file his application. Because claimant did not file his application for review within the time period allowed, and did not establish that he had good cause to file a late application for review, the application for review must be dismissed.

DECISION: Order No. 20-UI-145641 is affirmed. The late application for review of Order No. 20-UI-145642 filed March 26, 2020 is dismissed. Order No. 20-UI-145642 remains undisturbed.
