# EMPLOYMENT APPEALS BOARD DECISION 2020-EAB-0279

#### Affirmed Request to Reopen Denied

**PROCEDURAL HISTORY:** On September 10, 2019 the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant did not actively seek work during the week of August 11 through 17, 2019 (week 33-19) and was ineligible for benefits for that week (decision # 145654). On September 30, 2019, decision # 145654 became final without claimant having requested a hearing. On December 4, 2019, the Department served notice of another administrative decision, based on decision # 145654, concluding that claimant was overpaid \$359 in benefits that she was required to repay to the Department or have deducted from future benefits otherwise payable to her (decision # 100732). On December 24, 2019, decision # 100732 became final without claimant having requested a hearing.

On January 13, 2020, claimant filed late requests for hearing on decisions #145654 and #100732. ALJ Kangas reviewed the requests, and on January 27, 2020 issued Orders No. 20-UI-143335 and 20-UI-143336, dismissing claimant's hearing requests as late without a showing of good cause, subject to claimant's right to renew the requests by responding to an appellant questionnaire by February 10, 2020. On January 31, 2020, claimant filed a timely response to the questionnaire. On February 4, 2020, the Office of Administrative Hearings (OAH) issued a letter stating that Orders No. 20-UI-143335 and 20-UI-143336 were cancelled, and notifying claimant that a hearing would be scheduled to address the timeliness of claimant's hearing requests and, if appropriate, the merits of the underlying decisions on appeal.

On February 18, 2020, OAH served notice of a consolidated hearing scheduled for March 3, 2020. On March 3, 2020, claimant failed to appear at the hearing, and ALJ Frank issued Orders No. 20-UI-145531 and 20-UI-145532, dismissing claimant's requests for hearing for failure to appear, leaving decisions # 145654 and # 100732 undisturbed. On March 17, 2020, claimant filed a timely request to reopen the March 3, 2020 hearing. ALJ Kangas considered claimant's request, and on March 24, 2020 issued Orders No. 20-UI-146822 and 20-UI-146819 denying the request, leaving Orders No. 20-UI-145531 and No. 20-UI-145532 undisturbed.

On March 31, 2020, claimant filed timely applications for review of Orders No. 20-UI-146822 and 20-UI-146819 with the Employment Appeals Board (EAB). Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Orders No. 20-UI-146822 and 20-UI-146819. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2020-EAB-0278 and 2020-EAB-0279).

With her applications for review, claimant submitted a written argument. However, claimant's argument contained information that was not part of the hearing record, and did not show that factors or circumstances beyond claimant's reasonable control prevented them from offering the information during the hearing. Under ORS 657.275(2) and OAR 471-041-0090 (May 13, 2019), EAB considered only information received into evidence at the hearing when reaching this decision.

EAB reviewed the entire consolidated hearing record. On *de novo* review and pursuant to ORS 657.275(2), the orders under review are **adopted**.

DECISION: Order Nos. 20-UI-146822 and 20-UI-146819 are affirmed.
