

EMPLOYMENT APPEALS BOARD DECISION
2020-EAB-0284

Application for Review Dismissed

FINDINGS OF FACT AND PROCEDURAL HISTORY: On November 19, 2019, the Oregon Employment Department (the Department) served notice of an administrative decision concluding the employer discharged claimant for misconduct connected with work (decision # 133723). Claimant filed a timely request for hearing. On January 9, 2020, ALJ Vaughn conducted a hearing, and on January 13, 2020 issued Order No. 20-UI-142536, concluding claimant voluntarily left work without good cause. On January 16, 2020, claimant filed an application for review with the Employment Appeals Board (EAB). On February 20, 2020, the EAB issued Decision No. 2020-EAB-0057, reversing Order No. 20-UI-142536 and remanding the case for another hearing and order. On March 12, 2020, ALJ Vaughn conducted another hearing and issued Order No. 20-UI-146125, again concluding claimant voluntarily left work without good cause. Order No. 20-UI-146125 stated that any appeal from the order had to be filed on or before April 1, 2020 to be timely. Claimant mailed an application for review to EAB on April 2, 2020, as evidenced by the postmark affixed to the envelope by the United States Postal Service (USPS).

CONCLUSIONS AND REASONS: The application for review should be dismissed.

Claimant filed his application for review of Order No. 20-UI-146125 by mail. If an application for review is mailed, “the filing date is the date the document is deposited in the United States mail in an envelope with first class postage, as evidenced by the postmark affixed to the envelope by the United States Postal Service.” OAR 471-041-0065(1)(b) (May 13, 2019). Here, the postmark shows that claimant’s application for review was mailed, and therefore filed, on April 2, 2020.

ORS 657.270(6) and ORS 657.270(7)(b) required the application for review to be filed no later than April 1, 2020. The deadline for filing a late application for review may be extended under certain circumstances. OAR 471-041-0070. In order to be considered for such an extension, however, an individual must include “a written statement describing the circumstances that prevented a timely filing.” OAR 471-041-0070(3). The appellant provided no explanation as to why the application was filed after the filing deadline expired. Accordingly, the application for review is dismissed.

DECISION: The application for review filed April 2, 2020 is dismissed. Order No. 20-UI-146125 remains undisturbed.
