

**EMPLOYMENT APPEALS BOARD DECISION**  
**2020-EAB-0286**

*Application for Review Dismissed*

**FINDINGS OF FACT AND PROCEDURAL HISTORY:** On February 3, 2020, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant was not available for work from January 5, 2020 through January 11, 2020 (decision # 140847). On February 24, 2020, decision # 140847 became final without claimant having filed a timely request for hearing. On March 10, 2020, claimant filed a late request for hearing. On March 12, 2020, ALJ Kangas issued Order No. 20-UI-146093, dismissing claimant's late request for hearing subject to claimant's right to renew the request by responding to an appellant questionnaire by March 26, 2020. On April 1, 2020, Order No. 20-UI-146093 became final without claimant having either responded to the questionnaire or filed a timely application for review of the order. On April 6, 2020, claimant filed a late application for review with EAB.

**CONCLUSIONS AND REASONS:** The application for review should be dismissed.

On April 6, 2020, the appellant filed an application for review of Order No. 20-UI-146093 with EAB. ORS 657.270(6) and ORS 657.270(7)(b) required the application for review to be filed no later than April 1, 2020. The deadline for filing a late application for review may be extended under certain circumstances. OAR 471-041-0070. In order to be considered for such an extension, however, an individual must include "a written statement describing the circumstances that prevented a timely filing." OAR 471-041-0070(3). The appellant provided no explanation as to why the application was filed after the filing deadline expired. Accordingly, the application for review is dismissed.

**DECISION:** The application for review filed April 6, 2020 is dismissed. Order No. 20-UI-146093 remains undisturbed.
