

**EMPLOYMENT APPEALS BOARD DECISION**  
**2020-EAB-0294**

*Affirmed*  
*Late Request for Hearing Dismissed*

**PROCEDURAL HISTORY:** On December 9, 2019, the Oregon Employment Department (the Department) served notice of an administrative decision concluding the employer discharged claimant for misconduct, and claimant was disqualified from receiving unemployment insurance benefits effective November 3, 2019 (decision # 131754). On December 30, 2019, decision # 131754 became final without claimant having filed a request for hearing. On December 31, 2019, claimant filed a late request for hearing. On January 16, 2020, ALJ Kangas issued Order No. 20-UI-142760, dismissing claimant's late request for hearing as untimely, subject to claimant's right to renew the request by responding to an appellant questionnaire by January 30, 2020. On January 22, 2020, claimant responded to the appellant questionnaire. On February 4, 2020, the Office of Administrative Hearings (OAH) issued a letter stating that Order No. 20-UI-142760 was canceled. On February 6, 2020, OAH served notice of hearing scheduled for February 19, 2020, on whether claimant's late requests for hearing should be allowed and, if so, the merits of decision # 131754. On February 10, 2020, OAH served a change notice of hearing, rescheduling the hearing for March 2, 2020. On March 6, 2020, OAH served another change notice of hearing, rescheduling the hearing for March 18, 2020. On March 18, 2020, ALJ S. Lee conducted a hearing, and on March 25, 2020 issued Order No. 20-UI-146898, re-dismissing claimant's late request for hearing on decision # 131754 as without good cause. On April 13, 2020, claimant filed a timely application for review of Order No. 20-UI-146898 with the Employment Appeals Board (EAB).

Claimant did not declare that they provided a copy of their argument to the opposing party or parties as required by OAR 471-041-0080(2)(a) (May 13, 2019). The argument also contained information that was not part of the hearing record, and did not show that factors or circumstances beyond claimant's reasonable control prevented them from offering the information during the hearing as required by OAR 471-041-0090 (May 13, 2019). EAB considered only information received into evidence at the hearing when reaching this decision. *See* ORS 657.275(2).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

**DECISION:** Order No. 20-UI-146898 is affirmed.
