

**EMPLOYMENT APPEALS BOARD DECISION**  
**2020-EAB-0295**

*Application for Review Dismissed*

**FINDINGS OF FACT AND PROCEDURAL HISTORY:** On November 14, 2018, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant was not available for work from November 13, 2016 through March 4, 2017 (decision # 92258). On November 15, 2018, the Department served notice of an administrative decision assessing a \$7,162 overpayment, \$2,148.60 monetary penalty, and 52 weeks penalty weeks (decision # 194811). On December 3, 2018, claimant filed a timely request for hearing on decision # 194811. On December 4, 2018, decision # 92258 became final without claimant having filed a timey request for hearing. On December 11, 2018, claimant filed a late request for hearing of decision # 92258. On January 9, 2019, ALJ M. Davis conducted a hearing, and on January 10, 2019 issued Order No. 19-UI-122518, allowing claimant's late request for hearing on decision # 92258 and affirming that decision, and Order No. 19-UI-122521, modifying decision # 194811 by concluding claimant was liable for a \$7,160 overpayment, \$2,148 monetary penalty, and 52 penalty weeks. On January 30, 2019, Order Nos. 19-UI-122518 and 19-UI-122521 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). In April 2020, claimant filed a late application for review with EAB.

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Orders Nos. 19-UI-122518 and 19-UI-122521. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2020-EAB-0296 and 2020-EAB-0295).

**CONCLUSIONS AND REASONS:** The application for review should be dismissed.

In April 2020, the appellant filed an application for review of Order Nos. 19-UI-122518 and 19-UI-122521 with the EAB. ORS 657.270(6) and ORS 657.270(7)(b) required the application for review to be filed no later than January 30, 2019. The deadline for filing a late application for review may be extended under certain circumstances. OAR 471-041-0070. In order to be considered for such an extension, however, an individual must include "a written statement describing the circumstances that prevented a timely filing." OAR 471-041-0070(3). The appellant provided no explanation as to why the application was filed after the filing deadline expired. Accordingly, the application for review is dismissed.

**DECISION:** The application for review filed in April 2020 is dismissed. Order Nos. 19-UI-122518 and 19-UI-122521 remain undisturbed.
