

EMPLOYMENT APPEALS BOARD DECISION
2020-EAB-0308

Affirmed
Late Request for Hearing Dismissed

PROCEDURAL HISTORY: On February 27, 2020, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant voluntarily left work without good cause and disqualifying claimant from receiving unemployment insurance benefits effective January 19, 2020 (decision # 130452). On March 18, 2020, the decision became final without claimant having filed a request for hearing. On March 19, 2020, claimant filed a late request for hearing. On March 24, 2020, ALJ Kangas issued Order No. 20-UI-146777, dismissing claimant's late request for hearing subject to her right to renew the request by responding to an appellant questionnaire by April 7, 2020. Claimant returned a timely response to the appellant questionnaire to the Office of Administrative Hearings (OAH). On April 13, 2020, ALJ Kangas issued Order No. 20-UI-147904, canceling Order No. 20-UI-146777 and re-dismissing claimant's request for hearing on decision # 130452. On April 16, 2020, claimant filed a timely application for review of Order No. 20-UI-147904 with the Employment Appeals Board (EAB).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 20-UI-147904 is affirmed.
