

EMPLOYMENT APPEALS BOARD DECISION
2020-EAB-0315

Affirmed
Late Request for Hearing Dismissed

PROCEDURAL HISTORY: On March 15, 2017, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant willfully made misrepresentations and failed to report material facts to obtain benefits, and assessing a \$705 overpayment, a \$176.25 monetary penalty, and 5 penalty weeks (decision # 194329). On April 4, 2017, decision # 194329 became final without claimant having filed a timely request for hearing.

On March 27, 2020, claimant filed a late request for hearing. On April 8, 2020, ALJ Kangas issued Order No. 20-UI-147651, dismissing claimant's late request for hearing, subject to claimant's right to renew the request by responding to an appellant questionnaire by April 22, 2020. On April 12, 2020, claimant filed a timely response to the appellant questionnaire. ALJ Kangas reviewed claimant's questionnaire response and on April 21, 2020, issued Order No. 20-UI-148477, concluding claimant did not show good cause for the late request for hearing, canceling Order No. 20-UI-147651, re-dismissing claimant's late request for hearing, and leaving decision # 194329 undisturbed. On April 24, 2020, claimant filed a timely application for review of Order No. 20-UI-148477 with the Employment Appeals Board (EAB).

EAB considered claimant's written argument in reaching this decision.

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 20-UI-148477 is affirmed.
