

EMPLOYMENT APPEALS BOARD DECISION
2020-EAB-0320

Affirmed
Request to Reopen Denied

PROCEDURAL HISTORY: On February 21, 2020, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant quit work without good cause and was disqualified from receiving unemployment insurance benefits effective August 4, 2019 (decision # 142520). Claimant filed a timely request for hearing. On March 19, 2020, the Office of Administrative Hearings mailed notice of a hearing scheduled for April 2, 2020. On April 2, 2020, claimant failed to appear at the hearing, and ALJ S. Roberts issued Order No. 20-UI-147328, dismissing claimant's request for hearing for failure to appear.

On April 13, 2020, claimant filed a timely request to reopen the April 2, 2020 hearing. ALJ Kangas reviewed claimant's request to reopen, and on April 22, 2020, issued Order No. 20-UI-148565, denying the request. On April 27, 2020, claimant filed a timely application for review of Order No. 20-UI-148565 with the Employment Appeals Board (EAB).

Claimant submitted a written argument their application for review. However, claimant did not declare that they provided a copy of their argument to the opposing party or parties as required by OAR 471-041-0080(2)(a) (May 13, 2019). The argument also contained information that was not part of the hearing record, and did not show that factors or circumstances beyond claimant's reasonable control prevented them from offering the information with their request to reopen as required by OAR 471-040-0040 (February 10, 2012). EAB considered only information included within the record when reaching this decision. *See* ORS 657.275(2).

EAB reviewed the entire record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**. Order No. 20-UI-147328 remains undisturbed.

DECISION: Order No. 20-UI-148565 is affirmed.
