

**EMPLOYMENT APPEALS BOARD DECISION**  
**2020-EAB-0329**

*Affirmed*  
*Late Request for Hearing Dismissed*

**PROCEDURAL HISTORY:** On February 12, 2020, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant was paid benefits to which claimant was not entitled and assessing a \$447 overpayment which claimant was liable to have deducted from future benefits otherwise payable to claimant within the five year period following the week in which the decision became final (decision # 84209). On March 3, 2020, decision #84209 became final without claimant having filed a timely request for hearing.

On March 9, 2020, claimant filed a late request for hearing. On March 12, 2020, ALJ Kangas issued Order No. 20-UI-146068, dismissing claimant's late request for hearing subject to claimant's right to renew the request by responding to an appellant questionnaire by March 26, 2020. On March 19, 2020, claimant filed a timely response to the appellant questionnaire. On March 26, 2020, the Office of Administrative Hearings (OAH) mailed a letter to the parties stating that Order No. 20-UI-146068 was canceled.

On April 1, 2020, OAH served notice of a hearing scheduled for April 15, 2020 at 9:30 a.m. On April 15, 2020, ALJ Wyatt conducted an interpreted hearing with a certified Vietnamese interpreter, and on April 17, 2020, issued Order No. 20-UI-148267, concluding claimant failed to show good cause for the late request for hearing and dismissing the hearing request for that reason, leaving decision # 84209 undisturbed. On April 24, 2020, claimant filed a timely application for review of Order No. 20-UI-148267 with the Employment Appeals Board (EAB).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**. Decision # 84209 remains undisturbed.

**DECISION:** Order No. 20-UI-148267 is affirmed.
