# EMPLOYMENT APPEALS BOARD DECISION 2020-EAB-0334

Affirmed
Late Request to Reopen Denied

PROCEDURAL HISTORY: On September 5, 2019, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant was not able to work from August 11, 2019 to August 31, 2019, and until the reason for the denial ended (decision # 155927). On September 11, 2019, claimant filed a timely request for hearing. On September 18, 2019, the Office of Administrative Hearings (OAH) served, by mail, notice of a hearing scheduled for October 2, 2019. On October 2, 2019, claimant failed to appear at the hearing, and on October 3, 2019 ALJ Shoemake issued Order No. 19-UI-137445, dismissing claimant's request for hearing due to her failure to appear. On October 23, 2019, Order No. 19-UI-137445 became final without claimant having filed a request to reopen the October 2, 2019 hearing. On April 2, 2020, claimant filed, by email, a late request to reopen the hearing. ALJ Kangas reviewed claimant's late request to reopen and, on April 17, 2020, issued Order No. 20-UI-148260, denying the request. On April 19, 2020, claimant filed an application for review with the Employment Appeals Board (EAB).

EAB considered claimant's written argument in reaching this decision.

**FINDINGS OF FACT:** (1) Claimant was aware that OAH had scheduled her hearing for October 2, 2019; however, she "did not log-in to the hearing because [she] was in the middle of being hired by the North Santiam School District as a Substitute and [her] start date was October 15, 2019." DR Exhibit 5.

(2) Claimant misunderstood the purpose of the October 2, 2019 hearing, but after speaking to a family friend, she understood its purpose.

**CONCLUSIONS AND REASONS:** Claimant's late request to reopen is denied.

ORS 657.270(5) provides that any party who failed to appear at a hearing may request to reopen the hearing, and the request will be allowed if it was filed within 20 days of the date the hearing decision was issued and shows good cause for failing to appear. The period within which a party may request reopening may be extended if the party requesting reopening has good cause for failing to request reopening within the time allowed, and acts within a reasonable time. OAR 471-040-0041(1) (February

10, 2012). "Good cause" exists when an action, delay, or failure to act arises from an excusable mistake or from factors beyond an applicant's reasonable control. OAR 471-040-0041(2). "A reasonable time," is seven days after the circumstances that prevented a timely filing ceased to exist. OAR 471-040-0041(3). The party requesting reopening shall set forth the reason(s) for filing a late request to reopen in a written statement, which OAH shall consider in determining whether good cause exists for the late filing, and whether the party acted within a reasonable time. OAR 471-040-0041(4).

Although claimant provided a written statement attempting to explain why she missed the October 2, 2019 hearing, she failed to explain why she did not meet the 20-day deadline provided in ORS 657.270(5) for timely seeking to reopen the October 2, 2019 hearing. Because claimant did not explain the reason(s) she filed her request for reopen late, she has failed to establish good cause to allow for a late reopening of the hearing. Claimant's late request to reopen is denied.

**DECISION:** Order No. 20-UI-148260 is affirmed.
