

EMPLOYMENT APPEALS BOARD DECISION
2020-EAB-0343

Affirmed
Late Request for Hearing Dismissed

PROCEDURAL HISTORY: On June 23, 2017, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant willfully made misrepresentations and failed to report material facts to obtain benefits, and assessing a \$3,078 overpayment, a \$923.40 monetary penalty, and 22 penalty weeks (decision # 193558). On July 13, 2017, decision # 193558 became final without claimant having filed a timely request for hearing.

On April 7, 2020, claimant filed a late request for hearing. On April 22, 2020, ALJ Kangas issued Order No. 20-UI-148531, dismissing claimant's late request for hearing, subject to claimant's right to renew the request by responding to an appellant questionnaire by May 6, 2020. On April 27, 2020, claimant filed a timely response to the appellant questionnaire. ALJ Kangas reviewed claimant's questionnaire response and, on April 28, 2020, issued Order No. 20-UI-148855, concluding claimant did not show good cause for the late request for hearing, canceling Order No. 20-UI-148531, re-dismissing claimant's late request for hearing, and leaving decision # 193558 undisturbed. On May 4, 2020, claimant filed a timely application for review of Order No. 20-UI-148855 with the Employment Appeals Board (EAB).

EAB did not consider claimant's written argument when reaching this decision because they did not include a statement declaring that they provided a copy of their argument to the opposing parties as required by OAR 471-041-0080(2)(a) (May 13, 2019).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 20-UI-148855 is affirmed.
