

**EMPLOYMENT APPEALS BOARD DECISION**  
**2020-EAB-0347**

*Affirmed*  
*Late Request for Hearing Dismissed*

**PROCEDURAL HISTORY:** On September 14, 2017, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant willfully made misrepresentations and failed to report material facts to obtain benefits and assessing a \$2,592 overpayment, a \$777.60 monetary penalty, and 18 penalty weeks (decision # 194526). On October 4, 2017, decision # 194526 became final without claimant having filed a timely request for hearing.

On November 26, 2019, claimant filed a late request for hearing. On December 5, 2019, ALJ Kangas issued Order No. 19-UI-140753, dismissing claimant's late request for hearing subject to claimant's right to renew the request by responding to an appellant questionnaire by December 19, 2019. On April 3, 2020, claimant filed a late response to the appellant questionnaire.

On April 9, 2020, the Office of Administrative Hearings (OAH) mailed notice of a hearing scheduled for April 23, 2020 at 10:45 a.m. On April 23, 2020, ALJ Snyder conducted a hearing at which the employer did not appear, and on April 28, 2020, issued Order No. 20-UI-148839 concluding claimant failed to show good cause for his late request for hearing and dismissing claimant's late hearing request for that reason, leaving decision # 194526 undisturbed. On May 4, 2020 claimant filed a timely application for review of Order No. 20-UI-148839 with the Employment Appeals Board (EAB).

EAB considered claimant's written argument to the extent it was based on the hearing record.

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**. Decision # 194526 remains undisturbed.

**DECISION:** Order No. 20-UI-148839 is affirmed.
