EMPLOYMENT APPEALS BOARD DECISION
2020-EAB-0355

Order No. 20-UI-148732 Affirmed – Disqualification
Order No. 20-UI-148736 Affirmed – Overpayment, Penalties

PROCEDURAL HISTORY: On March 23, 2020, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant quit work without good cause and was disqualified from receiving unemployment insurance benefits effective October 13, 2019 (decision # 74558). On March 24, 2020, the Department served notice of another administrative decision concluding claimant willfully misrepresented a material fact to obtain benefits, and assessing claimant an overpayment of \$12,960, a monetary penalty of \$1,944, and 52 penalty weeks (decision # 202826). Claimant filed a timely request for hearing regarding both decisions. On April 22, 2020, ALJ Frank conducted a consolidated hearing regarding decisions # 74558 and 202826, and on April 24, 2020, issued Order No. 20-UI-148732, affirming decision # 74558, and Order No. 20-UI-148736, affirming decision # 202826. On May 9, 2020, claimant filed a timely application for review of Orders No. 20-UI-148732 and 20-UI-148736 with the Employment Appeals Board (EAB).

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Orders No. 20-UI-148732 and 20-UI-148736. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2020-EAB-0356 and 2020-EAB-0355).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the orders under review are **adopted**.

DECISION: Orders No. 20-UI-148732 and 20-UI-148736 are affirmed.
