

EMPLOYMENT APPEALS BOARD DECISION
2020-EAB-0370

Late Application for Review Dismissed

PROCEDURAL HISTORY: On March 13, 2020, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant was discharged for misconduct and was disqualified from receiving unemployment insurance benefits effective February 16, 2020 (decision # 160357). Claimant filed a timely request for hearing. On March 30, 2020, the Office of Administrative Hearings (OAH) mailed notice of a hearing for April 13, 2020. On April 13, 2020, ALJ S. Roberts conducted a hearing, and on April 14, 2020, issued Order No. 20-UI-147965, concluding that claimant was discharged not for misconduct. On May 4, 2020, Order No. 20-UI-147965 became final without the employer having filed an application for review with the Employment Appeals Board (EAB). On May 12, 2020, the employer filed a late application for review of Order No. 20-UI-147965 with EAB.

FINDINGS OF FACT: (1) Order No. 20-UI-147965 stated that any appeal of the order must be filed on or before May 4, 2020 to be timely.

CONCLUSIONS AND REASONS: The employer's late application for review of Order No. 20-UI-147965 is dismissed.

An application for review is timely if it is filed within 20 days of the date that OAH mailed the decision for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 20-UI-147965 was due May 4, 2020. Because the appellant did not file their application for review until May 4, 2020, the application for review was late. The employer provided a written statement with their application for review. However, the employer's written statement provided no information as to why the employer filed the application after the filing deadline.

Accordingly, the employer did not show good cause for the late application for review, and the employer's late application for review is dismissed.

DECISION: The application for review filed May 12, 2020 is dismissed. Order No. 20-UI-147965 remains undisturbed.
