EMPLOYMENT APPEALS BOARD DECISION 2020-EAB-0372

Late Application for Review Dismissed

PROCEDURAL HISTORY: On December 10, 2019, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant was not available for work from November 3 through November 30, 2019 and was ineligible for benefits for that period and until the reason for the denial had ended (decision # 155123). On December 30, 2019, decision # 155123 became final without claimant having filed a timely request for hearing.

On March 27, 2020, claimant filed a late request for hearing. On April 7, 2020, ALJ Kangas issued Order No. 20-UI-147567, dismissing claimant's request for hearing as late without a showing of good cause subject to claimant's right to renew the request by responding to an appellant questionnaire by April 21, 2020. On April 27, 2020, Order No. 20-UI-147567 became final without claimant having filed a response to the appellant questionnaire or an application for review of Order No. 20-UI-147567 with the Employment Appeals Board (EAB). On May 4, 2020, claimant filed a late response to the appellant questionnaire and a late application for review of Order No. 20-UI-147567 with EAB. On May 8, 2020, ALJ S. Lee mailed a letter to claimant stating that because claimant's response to the appellant questionnaire was late, the Office of Administrative Hearings (OAH) would not consider it or issue another hearing decision, and that Order No. 20-UI-147567 remained in effect. This matter comes before EAB based upon claimant's late application for review of Order No. 20-UI-147567.

EVIDENTIARY MATTER: EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence is claimant's late response to the appellant questionnaire, which has been marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit(s) will remain in the record.

FINDINGS OF FACT: (1) On April 7, 2020, OAH mailed Order No. 20-UI-147567 dismissing claimant's late request for hearing on decision # 155123 to claimant at her address of record on file with the Department. Order No. 20-UI-147567 gave claimant two options to request review of that decision. The first option was to provide additional information for consideration by OAH by timely responding

to the attached appellant questionnaire. The second option was to request review of the order by EAB. In that regard, the order stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 20-UI-147567 at 2.

CONCLUSIONS AND REASONS: Claimant's late application for review of Order No. 20-UI-147567 is dismissed.

An application for review is timely if it is filed within 20 days of the date that OAH mailed the decision for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

ORS 657.270(6) required claimant's application for review to be filed by April 27, 2020. Claimant filed her application for review on May 4, 2020, making the application for review late. While claimant's questionnaire response appeared to describe her unsuccessful attempts to timely request a hearing on decision #155123, in part because the response was dated April 13, 2020, it did not describe any circumstances that prevented a timely filing of an application for review of Order No. 20-UI-147567 by April 27, 2020. EAB Exhibit 1. Accordingly, because claimant failed to show that factors or circumstances beyond claimant's reasonable control prevented a timely filing of her application for review, good cause has not been shown and claimant's late application for review of Order No. 20-UI-147567 must be dismissed.

DECISION: The application for review filed May 4, 2020 is dismissed. Order No. 20-UI-147567 remains undisturbed.
