

EMPLOYMENT APPEALS BOARD DECISION
2020-EAB-0377

Affirmed
Late Request for Hearing Dismissed

PROCEDURAL HISTORY: On September 21, 2015, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant willfully made misrepresentations and failed to report material facts to obtain benefits, and assessed a \$2,283 overpayment, a \$684.90 monetary penalty, and a 17 week disqualification from future benefits (decision # 195047). On October 13, 2015, decision # 195047 became final without claimant having filed a timely request for hearing.

On April 1, 2020, claimant filed a late request for hearing. On April 22, 2020, ALJ Kangas issued Order No. 20-UI-148532, dismissing claimant's late request for hearing as late without a showing of good cause subject to her right to renew the request by responding to an appellant questionnaire by May 6, 2020. On May 5, 2020, claimant filed a timely response to the appellant questionnaire. ALJ S. Lee considered claimant's response, and on May 6, 2020 issued Order No. 20-UI-149326, re-dismissing claimant's late request for hearing as late without good cause. On May 11, 2020, claimant filed a timely application for review of Order No. 20-UI-149326 with the Employment Appeals Board (EAB).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 20-UI-149326 is affirmed.
