

**EMPLOYMENT APPEALS BOARD DECISION**  
**2020-EAB-0390**

*Affirmed*  
*Late Requests for Hearing Dismissed*

**PROCEDURAL HISTORY:** On August 7, 2019, the Oregon Employment Department (Department) served notice of an administrative decision concluding that claimant voluntarily left work without good cause and was disqualified from receiving unemployment insurance benefits effective May 26, 2019 (decision # 143101). On August 14, 2019, the Department served notice of an administrative decision concluding claimant voluntarily left work without good cause and was disqualified from receiving benefits effective June 30, 2019 (decision # 110202). On August 27, 2019, decision # 143101 became final without claimant having filed a request for hearing. On September 3, 2019, decision # 110202 became final without claimant having filed a request for hearing.

On April 6, 2020, claimant filed late requests for hearing on decisions # 143101 and 110202. On April 27, 2020, ALJ S. Lee issued Orders No. 20-UI-148789 dismissing claimant's late request for hearing on decision # 143101, and 20-UI-148787 dismissing claimant's late request for hearing on decision # 110202. Both Orders were issued subject to claimant's right to renew the request by responding to an appellant questionnaire by May 11, 2020. On May 11, 2020, claimant filed a timely response to the appellant questionnaire. ALJ Kangas reviewed claimant's response, and on May 13, 2020 issued Order No. 20-UI-149690 re-dismissing claimant's late request for hearing on decision # 143101, and Order No. 20-UI-149689 re-dismissing claimant's late request for hearing on decision # 110202.

On May 18, 2020, claimant filed timely applications for review of Orders No. 20-UI-149690 and 20-UI-149689. Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Orders No. 20-UI-149690 and 20-UI-149689. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2020-EAB-0389 and 2020-EAB-0390). EAB did not consider claimant's written argument when reaching this decision because they did not include a statement declaring that they provided a copy of their argument to the opposing party or parties as required by OAR 471-041-0080(2)(a) (May 13, 2019).

EAB reviewed the entire consolidated hearing record. On *de novo* review and pursuant to ORS 657.275(2), Orders No. 20-UI-149690 and 20-UI-149689 are **adopted**.

**DECISION:** Orders No. 20-UI-149690 and 20-UI-149689 are affirmed.
