No Disqualification

PROCEDURAL HISTORY: On March 9, 2020, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant quit work without good cause and was disqualified from receiving benefits effective December 29, 2019 (decision # 153422). On March 30, 2020, decision # 153422 became final without claimant having filed a request for hearing. On April 8, 2020, claimant filed a late request for hearing. On April 24, 2020, the Office of Administrative Hearings (OAH) mailed notice of a hearing scheduled for May 7, 2020 at 9:30 a.m. to determine whether claimant's late request for hearing should be allowed, and if so, the merits of decision # 153422. On May 7, 2020, ALJ Roberts conducted a hearing, and on May 8, 2020 issued Order No. 20-UI-149442, allowing claimant's late request for hearing and concluding claimant voluntarily quit work with good cause. On May 18, 2020, the employer filed a timely application for review with the Employment Appeals Board (EAB).

The employer submitted a written argument with their application for review. EAB did not consider the employer's written argument when reaching this decision because they did not include a statement declaring that they provided a copy of their argument to the opposing party or parties as required by OAR 471-041-0080(2)(a) (May 13, 2019).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 20-UI-149442 is affirmed.
