

EMPLOYMENT APPEALS BOARD DECISION
2020-EAB-0395

Affirmed
Late Request for Hearing Dismissed

PROCEDURAL HISTORY: On September 6, 2019, the Oregon Employment Department (the Department) served notice of an administrative decision concluding the employer discharged claimant for misconduct and that claimant was disqualified from receiving unemployment insurance benefits effective August 4, 2019 (decision # 163755). On September 26, 2019, decision # 163755 became final without claimant having filed a request for hearing. On April 13, 2020, claimant filed a late request for hearing. On April 27, 2020, ALJ Kangas issued Order No. 20-UI-148778 dismissing claimant's late request for hearing, subject to claimant's right to renew the request by responding to an appellant questionnaire by May 11, 2020. On May 6, 2020, claimant filed a timely response to the appellant questionnaire. ALJ S. Lee reviewed claimant's response, and on May 8, 2020 issued Order No. 20-UI-149495, concluding claimant did not show good cause for the late request for hearing, canceling Order No. 20-UI-148778, re-dismissing claimant's late request for hearing, and leaving decision # 163755 undisturbed. On May 18, 2020, claimant filed a timely application for review of Order No. 20-UI-149495 with the Employment Appeals Board (EAB).

EAB did not consider claimant's written argument when reaching this decision because claimant did not include a statement declaring that they provided a copy of their argument to the opposing parties as required by OAR 471-041-0080(2)(a) (May 13, 2019).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 20-UI-149495 is affirmed.
