

EMPLOYMENT APPEALS BOARD DECISION
2020-EAB-0397

Affirmed
Late Request for Hearing Dismissed

PROCEDURAL HISTORY: On January 31, 2020, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was not available for work during the week of January 5 through January 11, 2020, and was ineligible for benefits for that week and until the conditions that created the ineligibility ceased (decision # 103810). On February 20, 2020, decision # 103810 became final without claimant having filed a timely request for hearing. On April 9, 2020, claimant filed a late request for hearing. On April 28, 2020, ALJ Kangas issued Order No. 20-UI-148853, dismissing claimant's late request for hearing subject to claimant's right to renew the request by responding to an appellant questionnaire by May 12, 2020. On May 1, 2020, claimant filed a timely response to the appellant questionnaire. ALJ Kangas reviewed claimant's response, and on May 7, 2020 issued Order No. 20-UI-149421, concluding that claimant did not show good cause for his late request for hearing, cancelling Order No. 20-UI-148853 and re-dismissing claimant's late request for hearing, leaving decision # 103810 undisturbed. On May 18, 2020, claimant filed a timely application for review of Order No. 20-UI-149421 with the Employment Appeals Board (EAB).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**. Decision # 103810 remains undisturbed.

DECISION: Order No. 20-UI-149421 is affirmed.
