

**EMPLOYMENT APPEALS BOARD DECISION**  
**2020-EAB-0399**

*Application for Review Dismissed*

**FINDINGS OF FACT AND PROCEDURAL HISTORY:** On January 20, 2016, the Oregon Employment Department (the Department) served notice of an administrative decision assessing a \$2,052.00 overpayment, \$410.40 monetary penalty, and 15 penalty weeks (decision # 195055). Claimant filed a timely request for hearing. On April 8, 2016, ALJ Monroe conducted a hearing, and on April 15, 2016 issued Order No. 16-UI-57449, affirming the Department's decision. On May 5, 2016, Order No. 16-UI-57449 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On April 29, 2020, claimant filed a late application for review with EAB.

**CONCLUSIONS AND REASONS:** The application for review should be dismissed.

On April 29, 2020, the appellant filed an application for review of Order No. 16-UI-57449 with the EAB. ORS 657.270(6) and ORS 657.270(7)(c) required the application for review to be filed no later than May 5, 2016. The deadline for filing a late application for review may be extended under certain circumstances. OAR 471-041-0070. In order to be considered for such an extension, however, an individual must include "a written statement describing the circumstances that prevented a timely filing." OAR 471-041-0070(3). The appellant provided no explanation as to why the application was filed after the filing deadline expired. Accordingly, the application for review is dismissed.

**DECISION:** The application for review filed April 29, 2020 is dismissed. Order No. 16-UI-57449 remains undisturbed.
