

EMPLOYMENT APPEALS BOARD DECISION
2020-EAB-0403

Affirmed
Late Request for Hearing Dismissed

PROCEDURAL HISTORY: On March 17, 2020, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that it had completed its investigation with respect to claimant's "Request for Adjustment of Claim Determination" and that certain of claimant's wages and hours could not be added to his claim. On March 27, 2020, that decision became final without claimant having filed a timely request for hearing. On March 31, 2020, claimant filed a late request for hearing. On April 30, 2020, ALJ Kangas issued Order No. 20-UI-149046, dismissing claimant's late request for hearing subject to claimant's right to renew the request by responding to an appellant questionnaire by May 14, 2020. On May 4, 2020, claimant filed a timely response to the appellant questionnaire. ALJ S. Lee reviewed claimant's response, and on May 8, 2020 issued Order No. 20-UI-149491, concluding that claimant did not show good cause for his late request for hearing, cancelling Order No. 20-UI-149046 and re-dismissing claimant's late request for hearing, leaving the Department's March 17, 2020 decision undisturbed. On May 20, 2020, claimant filed a timely application for review of Order No. 20-UI-149491 with the Employment Appeals Board (EAB).

WRITTEN ARGUMENT: Claimant's argument contained information that was not part of the hearing record, and did not show that factors or circumstances beyond claimant's reasonable control prevented them from offering the information during the hearing. Under ORS 657.275(2) and OAR 471-041-0090 (May 13, 2019), EAB considered only information received into evidence at the hearing when reaching this decision.

EAB reviewed the entire case record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**. The Department's March 17, 2020 decision remains undisturbed.

DECISION: Order No. 20-UI-149491 is affirmed.
