

EMPLOYMENT APPEALS BOARD DECISION
2020-EAB-0417

Affirmed
Disqualification

PROCEDURAL HISTORY: On January 10, 2020, the Oregon Employment Department (the Department) served notice of an administrative decision concluding the employer discharged claimant for misconduct (decision # 124842). Claimant filed a request for hearing. On February 19, 2020, ALJ Kangas issued Order No. 20-UI-144748, dismissing claimant's request for hearing as late without a showing of good cause subject to his right to renew the request by responding to an appellate questionnaire by March 4, 2020. On February 25, 2020, claimant responded to the questionnaire. On March 4, 2020, the Office of Administrative Hearings (OAH) mailed a letter stating that Order No. 20-UI-144748 was cancelled, and on March 17, 2020 OAH mailed notice of a hearing scheduled for March 31, 2020. On March 31, 2020, ALJ Janzen conducted a hearing, and on April 1, 2020 issued Order No. 20-UI-147274, re-dismissing claimant's request for hearing as late without good cause. On April 8, 2020, claimant filed an application for review with the Employment Appeals Board (EAB).

On April 29, 2020, EAB issued Appeals Board Decision 2020-EAB-0288, reversing Order No. 20-UI-147274 and ordering that a hearing be held on the merits of decision # 124842. On April 30, 2020, OAH mailed notice of a hearing on decision # 124842 scheduled for May 13, 2020. On May 4, 2020, claimant filed a petition for judicial review of Order No. 20-UI-147274 with the Oregon Court of Appeals. On May 12, 2020, the Oregon Court of Appeals dismissed claimant's petition for judicial review. On May 13, 2020, ALJ Janzen began to conduct a hearing on decision # 124842, which was continued to May 15, 2020. On May 15, 2020, the ALJ concluded the hearing, and on May 19, 2020 issued Order No. 20-UI-149946, affirming decision # 124842. On May 27, 2020, claimant filed a timely application for review of Order No. 20-UI-149946 with EAB.

EAB did not consider claimant's written argument when reaching this decision because they did not include a statement declaring that they provided a copy of their argument to the opposing party or parties as required by OAR 471-041-0080(2)(a) (May 13, 2019). Claimant's argument also contained information that was not part of the hearing record, and did not show that factors or circumstances beyond claimant's reasonable control prevented them from offering the information during the hearing. Under ORS 657.275(2), OAR 471-041-0080(2)(a), and OAR 471-041-0090 (May 13, 2019), EAB considered only information received into evidence at the hearing when reaching this decision.

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 20-UI-149946 is affirmed.
