

EMPLOYMENT APPEALS BOARD DECISION
2020-EAB-0422

Affirmed
Late Request for Hearing Dismissed

PROCEDURAL HISTORY: On November 1, 2019, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant willfully made a misrepresentation and failed to report a material fact to obtain unemployment insurance benefits, and assessing 8 penalty weeks¹ (decision # 200537). On November 21 2019, decision # 200537 became final without claimant having filed a timely request for hearing. On April 24, 2020, claimant filed a late request for hearing. On May 11, 2020, ALJ Kangas issued Order No. 20-UI-149520, dismissing claimant's late request for hearing, subject to claimant's right to renew the request by responding to an appellant questionnaire by May 25, 2020. On May 18, 2020, claimant filed a timely response to the appellant questionnaire. ALJ Kangas reviewed claimant's questionnaire response and, on May 21, 2020, issued Order No. 20-UI-150132, concluding claimant did not show good cause for the late request for hearing, canceling Order No. 20-UI-149520, re-dismissing claimant's late request for hearing, and leaving decision # 200537 undisturbed. On May 26, 2020, claimant filed a timely application for review of Order No. 20-UI-150132 with the Employment Appeals Board (EAB).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 20-UI-150132 is affirmed.
