EMPLOYMENT APPEALS BOARD DECISION 2020-EAB-0437

Affirmed Late Request to Reopen Denied

PROCEDURAL HISTORY: On February 19, 2020, the Oregon Employment Department (the Department) served notice of an administrative decision concluding the employer discharged claimant for misconduct and claimant was disqualified from receiving unemployment insurance benefits effective January 5, 2020 (decision # 152153). On February 22, 2020, claimant filed a timely request for hearing. On March 5, 2020, the Office of Administrative Hearings (OAH) served, by mail, notice of a telephone hearing scheduled for March 19, 2020 at 8:15 a.m. On March 19, 2020, claimant failed to appear for the hearing, and ALJ Buckley issued Order No. 20-UI-146505 dismissing claimant's request for hearing for that reason. On April 8, 2020, Order No. 20-UI-146505 became final without claimant having filed a timely request to reopen.

On April 28, 2020, claimant filed a late request to reopen the March 19, 2020 hearing. ALJ S. Lee reviewed claimant's request, and on May 15, 2020, issued Order No. 20-UI-149828, denying claimant's late request to reopen, leaving Order No. 20-UI-146505 undisturbed. On June 3, 2020, claimant filed a timely application for review of Order No. 20-UI-149828.

With his application for review, claimant submitted a written argument. Claimant did not provide a copy of the argument to the employer as required under OAR 471-041-0080(2)(a) (May 13, 2019), and claimant's argument also contained information that was not part of the record, and did not show that factors or circumstances beyond claimant's reasonable control prevented them from offering the information with his request to reopen. Under ORS 657.275(2) and OAR 471-041-0090 (May 13, 2019), EAB considered only information within the case record when reaching this decision.

Even if EAB had considered claimant's new information, it would not have changed the outcome of this decision. Claimant asserted that he had moved from his prior address on February 27, 2020 and for that reason did not receive his mail and was unaware of the March 19, 2020 hearing. Written argument at 1. ORS 657.270(5) provides that any party who failed to appear at a hearing may request to reopen the hearing, and the request will be granted if it was filed within 20 days of the date the hearing decision was issued and shows good cause for failing to appear. "Good cause" exists when the requesting party's failure to appear at the hearing arose from an excusable mistake or from factors beyond the party's

reasonable control. OAR 471-040-0040(2) (February 10, 2012). However, good cause does not include failure to receive a document due to not notifying the Department or OAH of an updated address while the person is claiming benefits or if the person knows, or reasonably should know, of a pending appeal. OAR 471-040-0040(2)(b)(A). Here, claimant requested a hearing on decision # 152153 on February 22, 2020 and knew or reasonably should have known of his pending appeal on and after that date and did not notify the Department or OAH of an updated address.

EAB reviewed the entire record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**. Order No. 20-UI-146505 remains undisturbed.

DECISION: Order No. 20-UI-149828 is affirmed.
