

EMPLOYMENT APPEALS BOARD DECISION
2020-EAB-0439

Late Application for Review Dismissed

PROCEDURAL HISTORY AND FINDINGS OF FACT: On January 9, 2020, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant did not provide the Department with information requested to process their claim in accordance with prescribed rules and was ineligible to receive benefits for the week of December 29, 2019 through January 4, 2020 (decision # 112552). On January 29, 2020, decision # 112552 became final without claimant having filed a request for hearing. On March 9, 2020, claimant filed a late request for hearing. On May 4, 2020, ALJ Wyatt conducted a hearing, and on May 12, 2020 issued Order No. 20-UI-149625 dismissing claimant's request for hearing as late without good cause. On June 1, 2020, Order No. 20-UI-149625 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On June 3, 2020, claimant filed a late application for review of Order No. 20-UI-149625 with EAB.

CONCLUSIONS AND REASONS: Claimant's late application for review of Order No. 20-UI-149625 is dismissed.

An application for review is timely if it is filed within 20 days of the date that OAH mailed the decision for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 20-UI-149625 was due June 1, 2020. Because claimant did not file their application for review until June 3, 2020, the application for review was late. Claimant did not include a written statement describing the circumstances that prevented claimant from filing a timely application for review by the June 1, 2020 deadline. Accordingly, under OAR 471-041-0070(3), claimant did not show good cause for their late filing, and claimant's late application for review therefore is dismissed.

DECISION: The application for review filed June 3, 2020 is dismissed. Order No. 20-UI-149625 remains undisturbed.
