

EMPLOYMENT APPEALS BOARD DECISION
2020-EAB-0448

Affirmed
Adjustment of Claim Determination Denied

PROCEDURAL HISTORY: On December 6, 2019, the Oregon Employment Department (the Department) served notice of an administrative decision denying claimant's request to adjust his claim determination and concluding that wages and hours were correct as reported by Business Group Inc. On December 16, 2019, the December 6, 2019 decision became final without claimant having filed a request for hearing. On December 17, 2019, claimant filed a late request for hearing on the December 6, 2019 decision. On December 31, 2019, ALJ Kangas issued Order No. 19-UI-141943, dismissing claimant's late request for hearing, subject to his right to renew the request by responding to an appellant questionnaire by January 14, 2020. On January 3, 2020, claimant filed a timely response to the appellant questionnaire. On January 17, 2020, the Office of Administrative Hearings (OAH) cancelled Order No. 19-UI-141943 and on January 27, 2020, served notice of a hearing scheduled for February 7, 2020 on whether claimant's late request for hearing should be allowed and, if allowed, the merits of the December 6, 2019 decision. On February 7, 2020, ALJ Shoemake conducted a hearing and on February 14, 2020, issued Order No. 20-UI-144527, re-dismissing claimant's late request for hearing. On February 25, 2020, claimant filed a timely application for review of Order No. 20-UI-144527 with the Employment Appeals Board (EAB).

On March 24, 2020, EAB issued Appeals Board Decision 2020-EAB-0174, reversing Order No. 20-UI-144527 and ordering that a hearing be held on the merits of the Department's December 6, 2019 decision. On April 8, 2020, OAH mailed notice of a hearing on the December 6, 2019 decision scheduled for May 6, 2020. On May 6, 2020, ALJ Shoemake began to conduct a hearing on the December 6, 2019 decision, which was continued to May 15, 2020. On May 15, 2020, the ALJ concluded the hearing, and on May 21, 2020, issued Order No. 20-UI-150128, affirming the December 6, 2019 decision. On June 8, 2020, claimant filed a timely application for review of Order No. 20-UI-150128 with EAB.

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 20-UI-150128 is affirmed.
