

EMPLOYMENT APPEALS BOARD DECISION
2020-EAB-0453

Affirmed
Disqualification

PROCEDURAL HISTORY: On April 30, 2020, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant quit work without good cause and was disqualified from receiving unemployment insurance benefits effective February 9, 2020 (decision # 165337). Claimant filed a timely request for hearing. On June 2, 2020, ALJ Wymer conducted a hearing, and on June 3, 2020 issued Order No. 20-UI-150546, affirming the Department's decision. On June 9, 2020, claimant filed an application for review with the Employment Appeals Board (EAB).

Claimant did not declare that they provided a copy of their argument to the opposing party or parties as required by OAR 471-041-0080(2)(a) (May 13, 2019). The argument also contained information that was not part of the hearing record, and did not show that factors or circumstances beyond claimant's reasonable control prevented them from offering the information during the hearing as required by OAR 471-041-0090 (May 13, 2019). EAB considered only information received into evidence at the hearing when reaching this decision. *See* ORS 657.275(2).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 20-UI-150546 is affirmed.
