

EMPLOYMENT APPEALS BOARD DECISION
2020-EAB-0461

Affirmed
Late Request for Hearing Dismissed

PROCEDURAL HISTORY: On October 2, 2014, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant voluntarily left work without good cause (decision # 113938). On October 22, 2014, decision # 113938 became final without claimant having filed a request for hearing. On January 31, 2019, claimant filed a late request for hearing. ALJ Kangas reviewed claimant's request for hearing and on February 12, 2019, issued Order No. 19-UI-124526, dismissing claimant's request for hearing as late without a showing of good cause, subject to claimant's right to renew the request by responding to an appellant questionnaire by February 26, 2019. Because a copy of Order No. 19-UI-124526 was not sent to claimant's representative, on April 21, 2020, ALJ Kangas issued amended Order No. 20-UI-148417, dismissing claimant's request for hearing on decision # 113938 as late without a showing of good cause, subject to claimant's right to renew the request by responding to an appellant questionnaire by May 5, 2020. On May 2, 2020, claimant filed a timely response to the appellant questionnaire. On May 13, 2020, the Office of Administrative Hearings (OAH) mailed notice of a hearing on May 26, 2020 to consider claimant's late request for hearing, and if granted, the merits of decision # 113938. On May 26, 2020, ALJ Murdock conducted a hearing at which the employer failed to appear, and on May 28, 2020, issued Order No. 20-UI-150380, redissmissing claimant's late request for hearing as without good cause, leaving decision # 113938 undisturbed. On June 5, 2020, claimant filed a timely application for review with the Employment Appeals Board (EAB).

EAB did not consider claimant's written argument when reaching this decision because they did not include a statement declaring that they provided a copy of their argument to the opposing party or parties as required by OAR 471-041-0080(2)(a) (May 13, 2019).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 20-UI-150380 is affirmed.
