EMPLOYMENT APPEALS BOARD DECISION 2020-EAB-0466

Late Applications for Review Dismissed

Employment Department (the Department) served notice of two administrative decisions, one concluding claimant voluntarily left work without good cause and was disqualified from receiving unemployment insurance benefits effective January 26, 2020 (decision # 81147), and one concluding claimant did not actively seek work and was not eligible to receive benefits from January 26, 2020 through February 1, 2020 (decision # 84333). Claimant filed timely requests for hearings on both decisions. On May 6, 2020, ALJ Scott conducted a hearing on decision # 81147 at which the employer failed to appear, and on May 12, 2020 issued Order No. 20-UI-149574 concluding claimant quit work with good cause and was not disqualified from receiving unemployment benefits based on that work separation. On May 6, 2020, ALJ Scott conducted a separate hearing on decision # 84333, and on May 12, 2020 issued Order No. 20-UI-149575 affirming decision # 84333.

On June 1, 2020, Orders No. 20-UI-149574 and 20-UI-149575 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On June 15, 2020, claimant filed late applications for review of both orders.

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Orders No. 20-UI-149574 and 20-UI-149575. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2020-EAB-0466 and 2020-EAB-0465).

CONCLUSIONS AND REASONS: The applications for review are dismissed.

An application for review is timely if it is filed within 20 days of the date that OAH mailed the decision for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late

application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The applications for review of Orders No. 20-UI-149574 and 20-UI-149575 were due by June 1, 2020. The appellant did not file their applications for review until June 15, 2020. Claimant provided no statement as to why they filed the applications after the filing deadline expired. Because claimant did not file their application for review within the time period allowed, and did not establish that they had good cause to file a late application for review, the applications for review must be dismissed.

DECISION: The applications for review of Orders No. 20-UI-149574 and 20-UI-149575 filed June 15, 2020 are dismissed. Orders No. 20-UI-149574 and 20-UI-149575 remain undisturbed.
