

**EMPLOYMENT APPEALS BOARD DECISION**  
**2020-EAB-0468**

*Affirmed*  
*Requests to Reopen Denied*

**PROCEDURAL HISTORY:** On April 8, 2020, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was not available for work during the weeks including November 3, 2019 through January 4, 2020 (weeks 45-19 through 01-20) and was ineligible for benefits for those weeks (decision # 125236). On April 28, 2020, decision # 125236 became final without claimant having filed a request for hearing. On April 9, 2020, the Department served notice of another administrative decision, based, in part, on decision # 125236, concluding claimant had willfully made misrepresentations and failed to report material facts to obtain benefits, and imposing a \$6,809 overpayment, a \$2042.70 monetary penalty, and a 52 week penalty disqualification from future benefits (decision # 194356).

On April 29, 2020, claimant filed a late request for hearing on decision # 125236 and a timely request for hearing on decision # 194356. On May 18, 2020, the Office of Administrative Hearings (OAH) mailed claimant notice of a hearing scheduled for May 28, 2020 at 9:30 a.m. to address whether claimant had good cause for his late request for hearing on decision # 125236, and if so, the merits of that decision. On May 18, 2020, the Office of Administrative Hearings (OAH) mailed claimant notice of a hearing scheduled for May 28, 2020 at 10:45 a.m. regarding claimant's request for hearing on decision # 194356. On May 28, 2020, claimant failed to appear at both hearings, and ALJ Snyder issued Orders No. 20-UI-150365 and 20-UI-150369, dismissing claimant's requests for hearing for failure to appear, leaving decisions # 125236 and # 194356 undisturbed.

On May 29, 2020, claimant filed timely requests to reopen the May 28, 2020 hearings. ALJ Kangas considered claimant's requests, and on June 3, 2020 issued Orders No. 20-UI-150556 and 20-UI-150557 denying the requests.

On June 17, 2020, claimant filed timely applications for review of Orders No. 20-UI-150556 and 20-UI-150557 with the Employment Appeals Board (EAB). Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Orders No. 20-UI-150556 and 20-UI-150557. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2020-EAB-0472 and 2020-EAB-0468).

With each of claimant's applications for review, claimant submitted a written argument. Claimant did not provide a copy of the argument to the employer as required under OAR 471-041-0080(2)(a) (May 13, 2019), and claimant's argument also contained information that was not part of the record, and did not show that factors or circumstances beyond claimant's reasonable control prevented them from offering the information with the requests to reopen. Under ORS 657.275(2) and OAR 471-041-0090 (May 13, 2019), EAB considered only information within the case record when reaching these decisions.

EAB reviewed the entire consolidated case records. On *de novo* review and pursuant to ORS 657.275(2), the orders under review are **adopted**.

**DECISION:** Orders No. 20-UI-150556 and 20-UI-150557 are affirmed.
