EMPLOYMENT APPEALS BOARD DECISION 2020-EAB-0474

Application for Review Dismissed

PROCEDURAL HISTORY: On July 5, 2019, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant quit working for the employer without good cause, and he was disqualified from receiving benefits effective April 1, 2018 (decision # 151622). On July 25, 2019, the decision became final without claimant having filed a request for hearing. On November 12, 2019, claimant filed a late request for hearing. On November 18, 2019, ALJ Kangas issued Order No. 19-UI-139895, dismissing claimant's request for hearing as untimely without a showing of good cause, subject to his right to renew his request by filing a response to an appellant questionnaire by December 2, 2019. On November 25, 2019, claimant filed a timely response to the appellant questionnaire. On December 5, 2019, the Office of Administrative Hearings (OAH) vacated Order No. 19-UI-139895, and on December 20, 2019, OAH mailed notice of a hearing scheduled for January 3, 2020 on whether claimant's late request for hearing should be allowed, and if so, the merits of decision #151622. On January 3rd, claimant failed to appear, and ALJ Murdock issued Order No. 20-UI-142070, dismissing claimant's request for failure to appear. On February 4, 2020, claimant filed a late request to reopen the hearing. On March 17, 2020, OAH mailed notice of a hearing scheduled for March 31, 2020. On March 31, 2020, ALJ Murdock conducted a hearing on claimant's request and on April 7, 2020, issued Order No. 20-UI-147616, allowing claimant's request to reopen but denying claimant's late request for hearing, leaving the Department's decision undisturbed. On April 27, 2020, Order No. 20-UI-147616 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On June 8, 2020, claimant filed a late application for review of Order No. 20-UI-147616 with EAB.

CONCLUSIONS AND REASONS: The late application for review of Order No. 20-UI-147616 is dismissed.

On June 8, 2010, claimant filed an application for review of Order No. 20-UI-147616. An application for review is timely if it is filed within 20 days of the date that OAH mailed the decision for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20 day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the

circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3). The application for review therefore was late, and although the appellant included a written statement with his application for review, that statement provided no explanation as to why the application for review was filed after the filing deadline expired. Accordingly, the application for review is dismissed.

DECISION: The application for review filed June 8, 2020 is dismissed. Order No. 20-UI-147616 remains undisturbed.
