

EMPLOYMENT APPEALS BOARD DECISION
2020-EAB-0475

Application for Review Dismissed

FINDINGS OF FACT AND PROCEDURAL HISTORY: On March 3, 2020, the Oregon Employment Department (the Department) served notice of an administrative decision concluding the employer discharged claimant for misconduct, and he was disqualified from receiving benefits effective January 19, 2020 (decision # 112002). Claimant filed a timely request for hearing. On March 27, 2020, the Office of Administrative Hearings (OAH) mailed notice of a hearing scheduled for April 10, 2020. On April 10, 2020, ALJ Janzen conducted the hearing, and on April 13, 2020 issued Order No. 20-UI-147914, affirming decision # 112002. On May 4, 2020, Order No. 20-UI-147914 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On May 5, 2020, claimant filed a late application for review with EAB.

CONCLUSIONS AND REASONS: The application for review should be dismissed.

On May 5, 2020, the appellant filed an application for review of Order No. 20-UI-147914 with the EAB. ORS 657.270(6) and ORS 657.270(7)(c) required the application for review to be filed no later than May 4, 2020. The deadline for filing a late application for review may be extended under certain circumstances. OAR 471-041-0070. In order to be considered for such an extension, however, an individual must include “a written statement describing the circumstances that prevented a timely filing.” OAR 471-041-0070(3). The appellant provided no explanation as to why the application was filed after the filing deadline expired. Accordingly, the application for review is dismissed.

DECISION: The application for review filed May 5, 2020 is dismissed. Order No. 20-UI-147914 remains undisturbed.
