

**EMPLOYMENT APPEALS BOARD DECISION**  
**2020-EAB-0482**

*Application for Review Dismissed*

**PROCEDURAL HISTORY:** On March 1, 2020, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was not entitled to Trade Readjustment Allowance (TRA) benefits. Claimant filed a timely request for hearing. On March 16, 2020, the Office of Administrative Hearings (OAH) mailed notice of a hearing scheduled for April 2, 2020, at which time claimant failed to appear. On April 2, 2020, ALJ Murdock issued Order No. 20-UI-147382, dismissing claimant's hearing request for failure to appear. On April 16, 2020, claimant filed a timely request to reopen the April 2<sup>nd</sup> hearing. On April 28, 2020, OAH mailed notice of a hearing scheduled for May 12, 2020. On May 12, 2020, ALJ Monroe conducted a hearing, at which claimant appeared, and on May 15, 2020 issued Order No. 20-UI-149841, denying claimant's request to reopen the April 2<sup>nd</sup> hearing. On June 4, 2020, Order No. 20-UI-149841 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On June 8, 2020, claimant filed a late application for review with EAB.

**CONCLUSIONS AND REASONS:** The application for review should be dismissed.

On June 8, 2020, the appellant filed an application for review of Order No. 20-UI-149841 with the EAB, as established by the postmark date on the envelope in which claimant mailed the application for review. ORS 657.270(6) and ORS 657.270(7)(c) required the application for review to be filed no later than June 4, 2020. The deadline for filing a late application for review may be extended under certain circumstances. OAR 471-041-0070. In order to be considered for such an extension, however, an individual must include "a written statement describing the circumstances that prevented a timely filing." OAR 471-041-0070(3). Although the appellant submitted a written argument with the application for review, the argument did not explain why the application was filed four days after the filing deadline expired. Accordingly, the application for review is dismissed.

**DECISION:** The application for review filed June 8, 2020 is dismissed. Order No. 20-UI-149841 remains undisturbed.
